## Our Services...

*Our Hourly and Live-in Caregivers focus on assistance with daily activities so that you or your loved one can have the highest quality of life.*

- Social interaction and company
- Personal care (bathing, dressing, incontinence care, transfers)
- Daily household tasks (cooking, cleaning, laundry, shopping, etc.)
- Help with maintaining medication schedules and compliance
- Transportation within the community or for medical purposes
- Assist with telephone calls and correspondence
- Around-the-clock support and safeguard

## *Recommended Hourly Caregiver Rates...*

- PCA - \$15.00 per hour
- HHA - \$15.00 per hour
- CNA - \$15.00 per hour
- Driver - \$15.00 per hour

In addition to the above Caregiver hourly rate there is a \$5.60 per hour agency fee that is billed monthly.

## *Recommended Live-in Caregiver Rates...*

- Live-in/24 Hour Care is available at a weekly rate of \$980.00 for a **single person** household
- Live-in/24 Hour Care is available at a weekly rate of \$1,190.00 for a **two-person** household

In addition to the above Caregiver weekly rates there is a \$392.00 per week agency fee that is billed monthly. Live-In Caregivers are also available on a daily basis based on the above rates.



## *Additional Considerations...*

Live-in Caregiver travel expenses are paid by the client. The most economical means used.

Hourly Caregivers may charge mileage at \$.58 cents per mile (or the going IRS rate) when the client destination is more than 10 miles away. This is one way only.

There are 7 major holidays that Hourly Caregivers are paid at time and one half the rate: New Year Day, Easter, Memorial Day, July 4<sup>th</sup>, Labor Day, Thanksgiving and Christmas Day. (Live-in Caregivers receive an additional \$70 flat fee.)

Drivers may use their own vehicles to transport clients in which case they are paid \$.58 cents per mile (or the going IRS rate).
